- 18 have been enacted into law, of which
- 1 has been partially vetoed by the Governor.

### ASSEMBLY JOINT RESOLUTIONS

- 76 have been introduced in the assembly, of which
- 32 are in committee,
- 2 are in the senate,
- 4 have been laid on the table and
- 38 have been enrolled.
